EQUINE ADOPTION – _____

This agreement is for the adoption of the horse(s) noted below and is a fully binding contract between _____ (known as Adopter) and Easy Street Horse & Barnyard Rescue, Inc. (known as Easy Street Horse Rescue or ESHR), who is the current legal and proper owner of the horse(s).

ADOPTER: READ EACH SECTION, THEN INITIAL BESIDE NUMBER. BY INITIALING BESIDE EACH NUMBER ADOPTER ACKNOWLEDGES FULL UNDERSTANDING AND AGREEMENT TO ABIDE BY THIS CONTRACT IN ITS ENTIRETY. ALL LEGAL AND/OR COURT FEES NECESSARY TO ENFORCE THE CONTRACT WILL BE PAID BY THE ADOPTER.

1. PROPER CARE: The adopter agrees that the horse(s) will always receive proper equine care.

- Proper equine care includes proper feeding, farrier services, veterinarian services and other care that is standard for quality care of a horse. **Customized hands-on instructions for the specific horse and owner will be given to each adopter by an ESHR Volunteer prior to completion of adoption, and will be attached to this contract as appendix A.** At all times the adopting home agrees to follow these instructions, treat the horse lovingly and humanely, and under no circumstances will tolerate any type of abuse to the animal.
- All horses adopted from Easy Street Horse Rescue are strictly for non-breeding purposes and not to be used in any commercial horse racing. *If the animal being adopted is a female, the adopter agree and certifies not to breed the animal, or put the animal in proximity to a stud, either by accident or on purpose. Mares will not be adopted to a facility with a stud horse in residence. All male horses will be gelded prior to leaving ESHR.*
- No horse adopted may be used in any type of harness or commercial racing.
- No horse adopted may be kept in a facility without any other equines.
- If, under any circumstances, the horse(s) do not receive Proper Care, as defined in above paragraphs, Easy Street Horse Rescue reserves the legal right to pick up or have the horse returned immediately without delay, and the adoption will be null and void. No return of the adoption fee will be made should the horse be returned under these type circumstances. Any expenses incurred by Easy Street will be paid by adopter.

2. BOARDING LOCATION: The horse(s) adopted will be kept at:

- **Adopters agree to notify Easy Street Horse & Barnyard Rescue, Inc of any changes to this information within 24 hours prior to any such occurrence.**
- Adopters give ESHR permission to visit adopted horse(s) at any time, without prior notice. This permission does not expire.
- If Adopter moves the horse without advising Easy Street Horse Rescue as stated in this paragraph, then this adoption is void and ownership will revert back to Easy Street Horse Rescue. Except in the event of an emergency where the horse(s)' health may be endangered if not moved. Should that occur ESHR must be notified as quickly as possible thereafter.

3. FUTURE TRANSFER OF OWNERSHIP:

- **During the first year of ownership**, should the adopter decide not to keep the horse(s), it shall be returned to Easy Street Horse Rescue, unless otherwise put in writing. Otherwise, after the first year the **adopters agree that Easy Street Horse Rescue will have right of first refusal should the adopter ever want to sell or give the horse away.**
- Should Easy Street Horse Rescue waive this first right to the horse, then Easy Street Horse Rescue will be provided an adoption application completed by the potential new owner, of which ESHR will check references and site visit as per normal adoption of a horse(s). The adopters understand and agree that any potential new owners will be approved by ESHR. No transfer or sale of the horse is legal without Easy Street Horse Rescue's written approval.
- *The horse(s) may be returned to Easy Street Horse & Barnyard Rescue, Inc. during the life of the horse(s), for any reason.*
- The adopter understands and agrees that the horse will **never be sold via an auction.**

4. ADOPTED HORSE(S): All horses adopted from Easy Street Horse & Barnyard Rescue, Inc. are without any written or expressed intent for usage, behavior or performance. Horses are unpredictable prey animals and as such their behavior is unpredictable and can be dangerous. Nothing shall be inferred or implied except which is written in this contract.

6. ADOPTION FEE REFUNDABLE: The purpose of the adoption is a good fit between horse and new owner (adopter). Should there be any issues that make the adoption not successful; other than noted under part 1 above; the horse(s) may be returned to Easy Street Horse & Barnyard Rescue, Inc. with a full or partial return of the adoption fee according to the following:

- Within 7 days of adoption – 100% of adoption fee will be returned.
- Within 30 days of adoption – 30% of adoption fee will be returned.
- Within one year of adoption – 10% of adoption fee will be returned.
- *The horse(s) may be returned to Easy Street Horse & Barnyard Rescue, Inc. during the life of the horse(s), for any reason.*

7. We have read and agree to all terms of this Equine Adoption Agreement and attest that all information on the Adoption Application is true and accurate and becomes a part of this Adoption Agreement. We hold harmless Easy Street Horse & Barnyard Rescue, Inc., and all its employees and volunteers from any and all liability or responsibility for accident, damage, injury, or illness that may occur as a result of this adoption.
